Who are we?

Established by a criminal barrister from London, the **Schools Consent Project (SCP)** is a charity which sends lawyers and postgraduate law students into schools across the country to teach young people about consent and various sexual offences.



What do we do?

We deliver hour-long workshops to 11-18-year-olds on the legal definition of consent, how to identify consent, bystander intervention, the offences of rape, sexual assault and 'sexting', the ages of consent, responding to disclosures and ways to obtain help.

The workshop is delivered through a series of fun, interactive games and exercises aimed at gently challenging the students' misconceptions and bringing about safer, healthier interactions from the grassroots up.

By adopting a legal approach, we are able to address subjects that can otherwise feel challenging, sensitive or simply taboo. Our workshops give young people agency, enabling them to fully understand the law around sex and consent in order to make informed and sensible decisions.

Each workshop is delivered to a maximum of 35 students.

2 We're lawyer-led. We bring our professional experience into the classrooms and respond to students' questions with accuracy and authority.

3 We are the only organisation of its kind that provides legal education to school-age children. We believe that these conversations ought to be happening at a young age for there to be real and lasting change.

Aims

We aim to normalise conversations about consent. We believe that education is the surest preventative against sexually abusive behaviour in later life. We want to give young people a legal toolkit to change the culture in schools, universities and workplaces and to drive down sexual offending rates.

Sequenced, spiral curriculum

Our strong belief, now supported by the Department of Education's **statutory guidance** on relationships and sex education, is that consent conversations should be more than a one-off talk that are quickly forgotten.

We offer a full through-school consent curriculum which is a sequenced, spiral programme of workshops that can be tailored to schools' and students' requirements. This allows for:

- schools to choose from a range of content
- curated workshops for an individual year group to build on prior learning
- facilitation of regular, peer-led conversations to support the school's wider culture

Year group specific workshops

Each workshop focuses on a different topic that is age appropriate, and developmentally relevant to a specific year group, whilst reinforcing certain fundamentals year-on-year to support students' retention of these key messages.

Every workshop begins with a recap of the basics of consent and our key messages. Each workshop also includes information on specific sexual and communication offences.

The year group specific approach includes:

- Year 7:** Personal boundaries; opening up conversations
- Year 8:** Sharing nudes sexting
- Year 9:** Behaviour in and around school
- Year 10:** More intimate relationships including in the context of parties/alcohol



Year 11: House parties, communication in more serious or longer-term relationships

Year 12: Preparing for university/work life; abuse in the context of longer term relationships

Year 13: Adult life/university, conduct in the workplace, image-based harassment, where to go for help as an adult

We are able to further tailor the existing suite of workshops to address any school-specific concerns.

Parent seminars

We regularly speak with parents to enable them to support these discussions at home and ensure they feel properly informed about the content of our workshops. This also allows parents to feel confident about how the school is meeting (and exceeding) the regulatory requirements in delivering consent education. Consent education has the greatest impact when everyone is involved in the conversation.

Price

Our standard workshop fee for a one hour lawyer-led workshop on consent is £300 (ie, per group of up to 35 students). We offer a discounted rate to state schools of £250. Where a booking is from a non-school setting (eg. military/football clubs), or where a school requires us to produce bespoke content, our workshop fee is £500. For bookings of over 10 workshops, a 20% discount will be applied.
